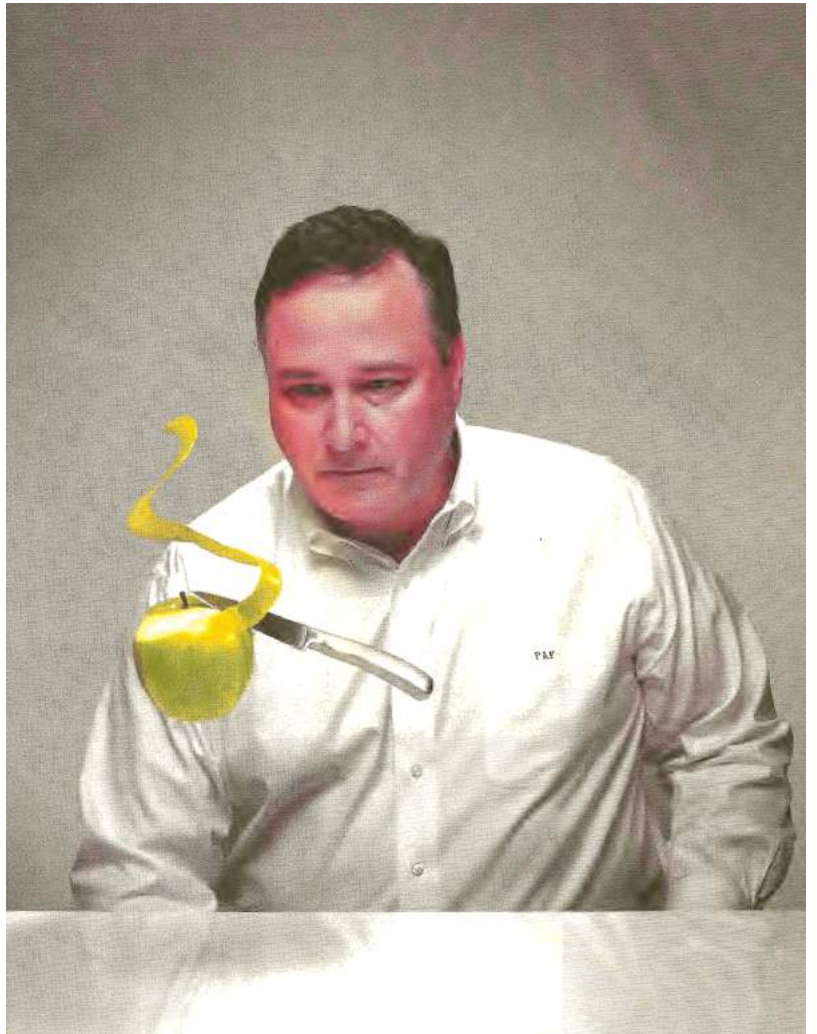
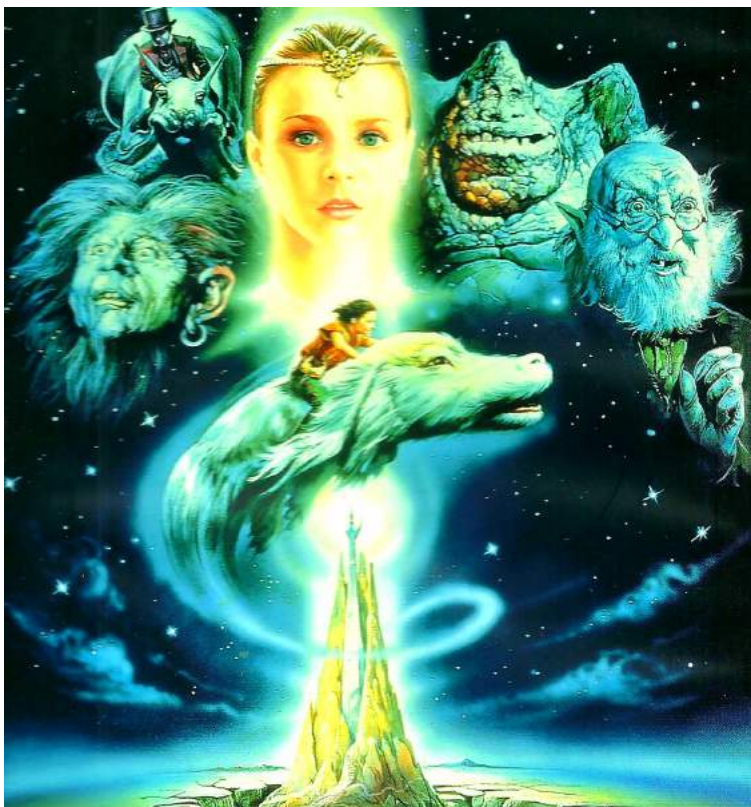

Articles have been published about “Mind over matter.” We see that our kind Father is allowing the devil and his poor slaves to do amazing miracles because the fiend “knoweth that he hath but a short time.” Rev. 12:12.

But in this letter you’re going to see that that’s not all our kind Father will permit him to do before he turns to ashes in the lake of fire.



Dear SDA friends around the world,

Read all the boxes in this letter, then come back here and we’ll talk about what’s happening.

Faith: The above Bible quote says, “the devil is come down unto you having great wrath, for he knoweth that he hath but a short time.” He knows the shortness of time better than we do. Will his fierce anger take away the rights of God’s people until he has his daughters sentence them to death? {Rev. 13:15}. How long will that take?

Pastor Jan: Are you ready? Here we go -

First, you see godly court rulings upholding the authority of the U.S. Constitution.

1) *Marbury v Madison*, 5 US (2 Cranch) 137, 174, 176; 2 LE 60 (1803) reveals that **“All laws which are repugnant to the Constitution are null and void.”**

2) *Miranda v Arizona*, 384 US 436, 491; 86 S Ct 1602; 16 L Ed 2d 694 (1966) reveals that **“Where rights secured by the Constitution are involved, there can be no legislation which would abrogate them.”**

3) *Norton v Shelby County, Tennessee*, 118 US 425, 442; 6 S Ct 1121; 30 L Ed 178 (1886) reveals that **“An unconstitutional act is not law; it confers no rights; it imposes no duties; affords no protection; creates no office. It is as inoperative as though it had never been passed.”**

4) *West Virginia State Board of Education v Barnette*, 319 US 624, 638; 63 S Ct 1178; 87 L Ed 1628 (1943) compared with *Romer v Evans*, 517 US 620; 116 S Ct 1620; 134 L Ed 2d 855 (1996) reveals - **“The very purpose of a Bill of Rights was to withdraw certain subjects from the vicissitudes of political controversy, to place them beyond the reach of majorities and officials and to establish them as legal principles to be applied by the courts. One’s right to life, liberty and property, to free speech, a free press, **freedom of worship and assembly**, and other fundamental rights may not be submitted to vote; they depend on the outcome of no election.”**

5) *Weimer v Bunbury*, 30 Mich 291; 1874 Mich. LEXIS 168 (1874) reveals that **“The Bill of Rights in the American Constitution has not been drafted for the introduction of new law, but to secure old [already existing] principles against abrogation or violation.”**

6) *Crandall v Nevada*, 73 US 35; 18 L Ed 745 (1868), & *Pinkerton v Verberg*, 78 Mich 573; 44 NW 579 (1889), reveals that **“One of the basic rights in the ‘Bill of Rights’ is ‘the basic constitutional right to travel. This Constitutional ‘right to travel’ has been used to strike down a number of politician-invented laws, devised on various fraudulent pretexts. [The prophet reveals that the Sunday law will also be “devised on various fraudulent pretexts” under a “plea of goodness.” Here’s the quote - “Human enactments, laws manufactured by satanic agencies under a plea of goodness and restriction of evil, will be exalted, while God’s holy commandments are despised and trampled underfoot. And all who prove their loyalty by obedience to the law of Jehovah must be **prepared** to be arrested, to be brought before councils that have not for their standard the high and holy law of God. [Are you and I “prepared to be arrested” for Jesus and for His law? Are we cowards who will cave in like Peter did?]**

“Those who live during the last days of this earth’s history will know what it means to be persecuted for the truth’s sake. In the courts injustice will prevail. The judges will refuse to listen to the reasons of those who are loyal to the commandments of God because they know that arguments in favor of the fourth commandment are unanswerable. They will say, ‘We have a law, and by our law he ought to die.’ God’s law is nothing to them. ‘Our law’ with them is supreme. Those who respect this human law will be favored, but those who will not bow to the idol sabbath will have no favors shown them.” *Maranatha*, p. 195.

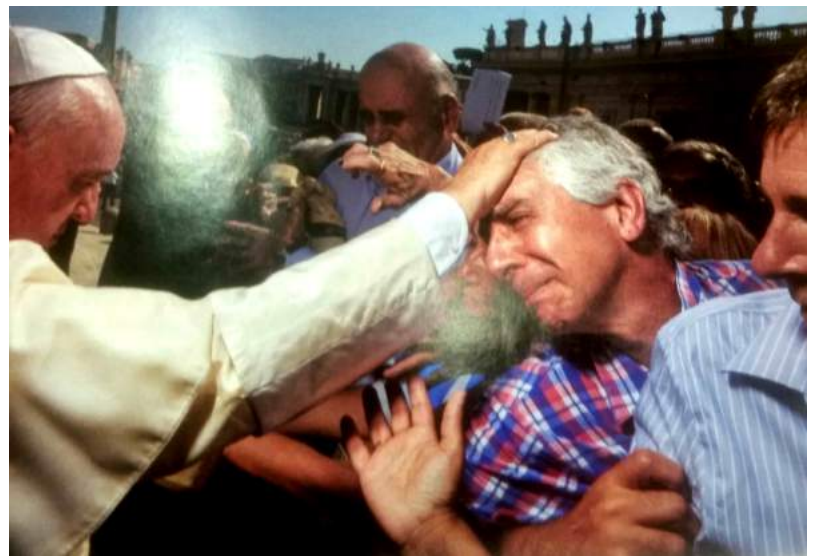
7) *Bonnett v Vallier*, 136 Wis 193, 200; 116 NW 885, 887 (1908); and *Ballard v Goodland*, 159 Wis 393, 395; 150 NW 488, 489 (1915); reveal that **unconstitutional enactments [laws] are treated as though they had never existed.**

8) The United States Constitution, based upon the notion of due process and fairness, bans ‘ex post facto’ laws. (It says, “No ex post facto Law shall be passed.” Constitution, Article I § 9). This means that, to be constitutional, a law must tell the citizenry IN ADVANCE, what act is contemplated by the prohibition of the law. It is not constitutional, to decide retroactively, after the fact, e.g., that what was done previously, was wrong.



9) *City of Oak Ridge v Diana Ruth Brown* (Tenn. Ct. App., Case No. E2004-01574-COA-R3-CV, 2005 WL 1996620, 19 August 2005 lv app den 2006) reveals that **a law is unconstitutional which forbids what the U.S. Constitution allows.**

10) *State v Lantz*, 90 W Va 738; 111 SE 766; 26 ALR 894 (1922) reveals that **a person who has an accident cannot be charged with the violation of a law unless every law for which he is supposed to have broken was plainly posted to him before the accident.**



The Pope’s great power.

“They will perform wonderful miracles of healing, and will profess to have revelations from heaven contradicting the testimony of the Scriptures...”

“But the people of God will not be misled. The teachings of this false christ are not in accordance with the Scriptures. His blessing is pronounced upon the worshipers of the beast and his image.” LDE 157.

Now, a number of modern court rulings contradict the U.S. Constitution. According to the Constitution, illegal laws are null, void, and aren't worth the paper they're written on. But the forces of evil know that as long as the ignorant masses don't realize what's happening, the wicked can get away with enforcing unconstitutional laws to keep controlling the masses as if the illegal laws were legal.

Thus, society has progressed closer and closer toward the coming of Jesus until now we are in a **mild police state**. That means that society no longer lives solely according to the highest written law of the land {the 10 Commandments and the U.S. Constitution} but largely lives by whatever the corrupt courts, the governor, the mayor, or the police officer mandates at the moment. Since they contradict each other, does God want us to obey the written law, or to obey these people?

We can obey both unless one of them commands you to disobey the ten commandments, the golden rule, or the Constitution. See Romans 13. Roman Catholic governors, mayors, and high officials [like the Speaker of the House] have given urgent mandates for the people to strictly obey [for the sake of protecting everyone from the virus,] and then the poor fiends are caught publicly breaking their own urgent mandates - showing the world that **they are no more afraid of the virus than you are!** 😊

In this intention he is aided by the Jesuits and all the Catholic prelates and priests." 11) "We want to make the press of this country a positive agency in the dissemination of Catholic ideas. [They have accomplished that!]" 12) "Protestantism, the murderous hag, is slowly dying of corruption and congenital rottenness, and she will not much longer encumber the earth." 13) "Those are not to be accounted murderers when burning with love and zeal for their Catholic mother against excommunicated Protestants, they shall happen to kill a few of them." 14) "If Catholics ever gain sufficient majority in this country, religious freedom is at an end." Pastor Jan: This June 27, 2015 article in World Net Daily reveals some of the more recent workings of papal controlled men in high positions.

THIS LAND WAS YOUR LAND

WASHINGTON – “Last week’s 5-4 Supreme Court decision broadened the eminent domain power - granting local governments sweeping powers to seize private property in order to generate tax revenue [for themselves].

Pastor Jan: The court also acknowledged that states can restrict that power. But the fiends know that the states will not interrupt their evil workings, because if the property owners tried to appeal the illegal “takeover” of their property, the judges [who also get money for their work] would just throw it out with the reason that the poor people have no “standing.”

Faith: When the wicked see dear Jesus coming in the clouds of heaven, will they have standing? Falling?

Pastor Jan: Here it is - “Their wails are heard above the sound of the elements. Demons acknowledge the deity of Christ and tremble before His power, while men are supplicating for mercy and groveling in abject terror.” GC 637.

““And the kings of the earth, and the great men, and the rich men, and the chief captains, and the mighty men, and every bondman, and every freeman, hid

themselves in the dens and in the rocks of the mountains; and said to the mountains and rocks, Fall on us, and hide us from the face of Him that sitteth on the throne, and from the wrath of the Lamb: for the great day of His wrath is come; and who shall be able to stand?” Rev 6:15-17.” GC 642.

The article continues -

“Currently, Arkansas, Florida, Georgia, Illinois, Kentucky, Maine, Montana, South Carolina, Virginia, and Washington already forbid the use of eminent domain for economic development unless it is to eliminate blight.

“But State House Minority Leader Ward said he has concerns about how the word ‘blight’ might be defined. [It’s no problem for the papacy because the officials define and interpret the meaning of their own illegal laws to harmonize with their “plea of goodness.” The prophet reveals that the coming Sunday law will also be made under a plea of goodness - “Human enactments, laws manufactured by satanic agencies under a **plea of goodness** and restriction of evil, will be exalted, while God’s holy commandments are despised and trampled underfoot.” Mar 195.]

“At least one legislator, Republican Sen. Tony Guglielmo, is calling on legislative leaders to **act...** Why should anyone

respect them for using our Constitution as toilet paper? This is communism, folks, pure and simple. Your right to own anything – be it your money, your opinion, or your home – is gone.

“Think I exaggerate? Consider how your rights have been systematically stolen from you...

“In 1913, the government falsely claimed the 16th Amendment was ratified and coerced vulnerable citizens – like you – into letting them take whatever it wants out of your wallet ... at the point of a gun if necessary.

“In 2003, the U.S. Supreme Court upheld by a 5-4 ruling the McCain-Feingold campaign-finance bill, which effectively gives the government the right to control speech it deems undesirable.

“A series of decisions in the last decade has upheld global government and has ceded control of U.S. sovereignty to the communist-controlled United Nations, including control of U.S. property.

“And in 2005, the U.S. Supreme Court decided local governments can take your home away from you if they want to. Where will this treason go next?”
