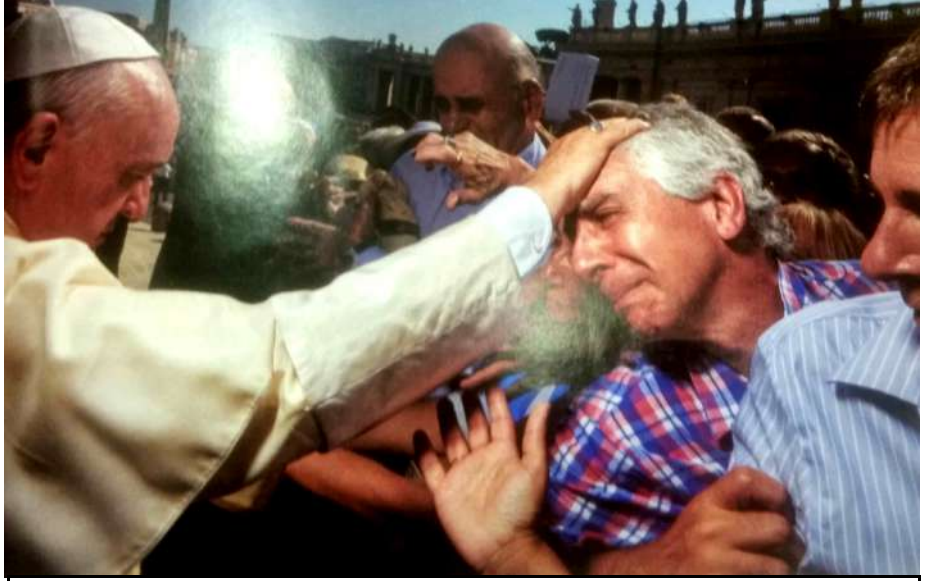

Dear SDA friends around the world,
Greetings in the holy name of Jesus.

Faith: The Bible verse says, “for the devil is come down unto you, having great wrath, because he knoweth that he hath but a short time.” Rev. 12:12.

What will his insane wrath cause the fiend to do even before the mark of the beast is enforced? And how will it affect God’s dear people?

Pastor Jan: Are you ready? Here we go -

Is it mind over matter? Or is it something else?

“Evil angels are upon our track every moment... Some will be tempted to receive these wonders as from God. The sick will be healed before us. **Miracles** will be performed in our sight. Are we prepared for the trial when the lying wonders of Satan shall be more fully exhibited?... Faith in **God’s word**, prayerfully **studied** and practically **applied** will be our shield from Satan’s power, and will bring us off conquerors through the blood of Christ.” RH 2/18/62.

The devil and his angels didn't know a lot of things when they first found themselves cast out of heaven. They didn't know that they were going to kill billions of people. Satan didn't know that he would even kill dear Jesus on a wooden cross. He didn't know that the papacy would ever exist as his girlfriend, or that he would use the church of Rome to infiltrate the Protestant world 6000 years later. Satan didn't know that he would trick the governments and religions of the world into enforcing the Sunday law in an effort to put God's dear people to death. And he didn't know that he would use the two-horned beast of Rev. 13 to repudiate its own Constitution and ignore court rulings that would prevent the enforcement of the mark of the beast.

Hope: What court rulings will be ignored so the devil's law can be passed? Are they being ignored already?

Pastor Jan: Here are some of them - 1) *Marbury v Madison*, 5 US (2 Cranch) 137, 174, 176; 2 LE 60 (1803) reveals that **"All laws which are repugnant to the Constitution are null and void."** In a minute you'll see that the dragon party is making many laws that violate the Constitution.

2) *Miranda v Arizona*, 384 US 436, 491; 86 S Ct 1602; 16 L Ed 2d 694 (1966) reveals that **"Where rights secured by the Constitution are involved, there can be no legislation which would abrogate them."** In a minute you'll see that the dragon party is violating that now.

3) *Norton v Shelby County, Tennessee*, 118 US 425, 442; 6 S Ct 1121; 30 L Ed 178 (1886) reveals that **"An unconstitutional act is not law; it confers no rights; it imposes no duties; affords no protection; creates no office. It is as inoperative as though it had never been passed."** In a minute you'll see that the dragon party is violating that now.

4) *West Virginia State Board of Education v Barnette*, 319 US 624, 638; 63 S Ct 1178; 87 L Ed 1628 (1943) compared with *Romer v Evans*, 517 US 620; 116 S Ct 1620; 134 L Ed 2d 855 (1996) reveals - **"One's right to life, liberty and property, to free speech, a free press, freedom of worship and assembly, and other fundamental rights may not be submitted to vote; they depend on the outcome of no election."** That has been violated by executive order.

5) *Weimer v Bunbury*, 30 Mich 291; 1874 Mich. LEXIS 168 (1874) reveals that **"The Bill of Rights in the American Constitution has not been drafted for the introduction of new law, but to secure old [already existing] principles against abrogation or violation."** In a minute you'll see that the dragon party is violating that now also.

6) *Crandall v Nevada*, 73 US 35; 18 L Ed 745 (1868), & *Pinkerton v Verberg*, 78 Mich 573; 44 NW 579 (1889), reveals that **"One of the basic rights in the 'Bill of Rights' is 'the basic constitutional right to travel. This Constitutional 'right to travel' has been used to strike down a number of politician invented laws, devised on various fraudulent pretexts."** [The prophet reveals that the Sunday law will also be "devised on various fraudulent pretexts" under a "plea of goodness." Here's the quote - "Human enactments, laws manufactured by satanic agencies under a plea of goodness and restriction of evil, will be exalted, [they're doing that now!] while God's holy commandments are despised and trampled underfoot. And all who prove their loyalty by obedience to the law of Jehovah must be prepared to be arrested, to be brought before councils that have not for their standard the high and holy law of God." 7BC 977.

"Those who live during the last days of this earth's history will know what it means to be persecuted for the truth's sake. In the courts injustice will prevail. The judges will refuse to listen to the reasons of those who are loyal to the commandments of God, because they know that arguments in favor of the fourth commandment are unanswerable. They will say, 'We have a law, and by our law he ought to die.' God's law is nothing to them. 'Our law' with them is supreme. Those who respect this human law will be favored, but those who will not bow to the idol sabbath will have no favors shown them." *Maranatha*, p. 195.

7) *Bonnett v Vallier*, 136 Wis 193, 200; 116 NW 885, 887 (1908); and *Ballard v Goodland*, 159 Wis 393, 395; 150 NW 488, 489 (1915); reveal that **unconstitutional enactments [laws] are treated as though they had never existed. In a minute you'll see that the dragon party is violating that now also.**

8) The United States Constitution, based upon the notion of due process and fairness, bans after the fact laws, i.e., 'ex post facto' laws. (It says, **"No ex post facto Law shall be passed."**)

Constitution, Article I § 9). This means that, to be constitutional, a law must tell the citizenry IN ADVANCE, what act is contemplated by the prohibition of the law. It is not constitutional, to decide retroactively, after the fact, e.g., that what was done previously, was wrong.

9) *People v Firth*, 3 NY2d 472; 168 NYS2d 949; 146 NE2d 682 (1957) reveals that **there can be no law that says that a motor vehicle's speed, which endangers life, limb, or property, is too fast. The court said that "Such a law is truly meaningless because there is no such thing as a motor vehicle speed incapable of endangering life, limb, or property."** [A car - only moving one inch at a time, is capable of killing a human against a wall or a tree. A friend of mine was killed against a wall by a car that was barely creeping by just inches. It pushed against his diaphragm so he couldn't breath. And there was no one around to put the car in reverse.] The court ruling said that "Such a law amounts to saying that if the driver is unable to bring his car to a stop without injuring someone, he is driving too fast." The court case said that that law was unconstitutional, and the law was struck down. The court realized that such laws would ban **all driving. The dragon party has been violating that for a long time.**

Since we are in a virtual police state now, if you want to escape punishment, you must do what the police tell you - regardless of what the U.S. Constitution says, but not regardless of what the law of God says. This brings to view the principle that Jesus taught us - **to not contend for our rights.** Here's the quote -

"Jesus did not contend for His rights. Often His work was made unnecessarily severe because He was willing and uncomplaining. Yet He did not fail nor become discouraged. He lived above these difficulties, as if in the light of God's countenance. He did not retaliate when roughly used, but bore insult patiently." DA 89.

10) *City of Oak Ridge v Diana Ruth Brown* (Tenn. Ct. App., Case No. E2004-01574-COA-R3-CV, 2005 WL 1996620, 19 August 2005 lv app den 2006) reveals that **a law is unconstitutional which forbids what the U.S. Constitution allows.** [There are piles of such laws.]

11) *State v Lantz*, 90 W Va 738; 111 SE 766; 26 ALR 894 (1922) reveals that **a person who has an accident cannot be charged with the violation of a law unless every law for which he is supposed to have broken was plainly posted to him before the accident.** The judge said, "One jury might say that a certain rate of speed was reasonable and proper. Another jury might reach exactly the opposite conclusion from exactly the same state of facts and the same circumstances." Today, that court case, as well as all the rest of these court rulings, are ignored.

12) In *Hayes v State*, 11 Ga App 371; 75 SE 523 (1912) the judge said, **"There is no reason why the Legislature should be permitted to set a dragnet and leave the courts to determine who shall be detained in the net and who should be set at liberty."**

13) *People v Earnest*, 33 Cal App 4th Supp 18 (14 Feb 1995) reveals that **"The Legislature strongly disapproves of speed traps,"** citing *People v Sullivan*, 234 Cal App 3d 56, 58-59; 285 Cal Rptr 553 (1991).

Pastor Jan: Now I'm going to show you some unconstitutional laws which the Supreme Court abolished. I counted 86 of them! Some of them were struck down because they were unconstitutional. Others were struck down because the majority of people on the Supreme Court are Roman Catholics.

The Vatican Warns of Coming Persecution

Dagon was the fish god of the Philistines. Here's a great papal man in the Vatican with a fish head like the priests of Dagon wore. VATICAN, November 28, 2011. One of the highest ranking cardinals in the Vatican has said that the United States is "well on the way" to the persecution of Christians.

Cardinal Raymond Burke, former Archbishop of St. Louis, told "Catholic News Agency" that he could envision a time when the Catholic Church in the U.S., "even by announcing her own teaching," is accused of "engaging in illegal activity, for instance, in its teaching on human sexuality."

Asked if the cardinal could even see American Catholics being arrested for their faith he replied, "I can see it happening, yes." [They speak of persecution coming to Catholics, when they know that it will come to God's Sabbath-keeping people for violating the law enforcing the mark of Rome "the mark of the beast."]

The pope told the bishops that "the seriousness of the challenges which the Church in America, under your leadership, is called to confront in the near future cannot be underestimated."

In the interview published today, Cardinal Burke declared that "it is a war" and "critical at this time that Christians stand up for the natural moral law." ["Natural law" is Roman Catholic law.] Should they not, he warned, "secularization will in fact predominate and it will destroy us."

He doesn't tell people that since the end of the Vatican II Council in 1965, Jesuit trained agents have oozed into high positions and fomented the very "secularization" which the Vatican will fight in its goal to "extend her influence and increase her power in preparation for a fierce and determined conflict to 1) regain control of the world, to 2) re-establish persecution, and to 3) undo all that Protestantism has done. Catholicism is gaining ground on every side." GC 565,566.

1) *June Medical Services LLC v. Russo*, No. 18-1323 (U.S. June 29, 2020). It was a law requiring abortion providers [baby killers] to have admitting privileges at hospitals within 30 miles of where an abortion is performed or induced.

If the Supreme Court had not struck it down, the law "required" that the wicked fiends be allowed to go into hospitals within 30 miles of where they murdered the babies. That way, Rome's agents could find more Protestant babies to murder. This is just a **small** part of the great thrust by the Vatican "new world order" to cause chaos while reducing the Protestant population so that Rome can take it over, [as millions of Catholics come in the country from the open borders, as revealed in the books, *Making America Catholic; 50 Years in the Church of Rome; and Great Controversy*. It's no wonder that Rome is preaching against abortion. Rev. 17:5 reveals the "MYSTERY" of why she preaches against the very things that

she is secretly doing. Look at all the aborted baby skeletons in convent lime pits. That subject is on CCA video #9. 2) Dawson v. Steager, No. 17-419 (U.S. Feb. 20, 2019). The crooked law was a statute providing a tax exemption for the retirement benefits of certain state law enforcement employees but not for federal retirees who had comparable job duties.

3) Murphy v. National Collegiate Athletic Ass'n, No. 16-476 (U.S. May 14, 2018). This law was struck down because it prohibited states from authorizing sports gambling schemes. Should states authorize gambling schemes? That law was struck down so that gambling schemes can flourish. {The reason why that could happen is because most of the Supreme Court justices are Roman Catholics - upholding the traditions of their church.} Gambling schemes began with "Bingo" in the Catholic churches and in the church yards where they had what they called bazaars. Now, papal Rome has spread herself until you see the word "slots" advertised most everywhere.

A bazaar is conducted in Catholic churches or church yards where they sell all kinds of stuff, and gamble. When I was a little boy my grandmother took me to a Roman Catholic church yard where they were having a bazaar and gambling with poker cards, a roulette wheel, and other devises of the devil.

4) National Institute of Family & Life Advocates v. Becerra, No. 16-1140 (U.S. June 26, 2018) This evil law was struck down because it forced pro-life clinics to promote government abortion services, which contradicted the

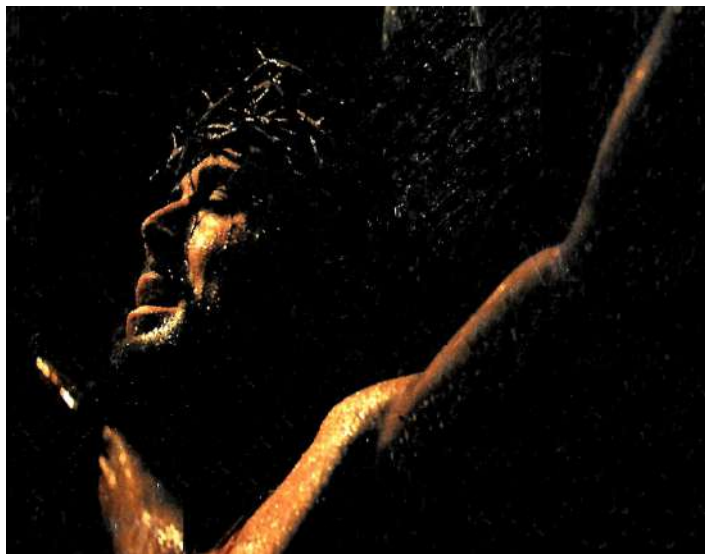

In order to gratify ambition and worldly desires, they wound the conscience, and bring upon themselves an additional burden of remorse. The continual worry is wearing out the life forces. Our Lord desires them to lay aside this yoke of bondage. He invites them to accept His yoke; He says, 'My yoke is easy, and My burden is light.' He bids them seek **first** the kingdom of God and His righteousness, and His promise is that **all** things needful to them for this life shall be added. **Worry is blind**, and cannot discern the future; but Jesus sees the end from the beginning. In every difficulty He has His way **prepared** to bring relief. **[Praise God!]** Our heavenly Father has a thousand ways to provide for us, of which we know nothing. Those who accept the **one** principle of making the service and honor of God supreme will find perplexities **vanish**, and a plain path before their feet.
